**PET CARE AGREEMENT**

is/are in good health, up to date on **Rabies, Bordetella, and DHPP vaccinations**, and has/have not been ill with any communicable condition in the last 45 days. **Flea, tick, and heartworm**, prevention is also required. If my dog(s) is/are brought to day care with fleas or ticks, the staff at K9 Cabin Dog Day Care will treat my dog with a flea bath at my expense.

You will receive reminders when vaccinations are due. It is your responsibility to provide on-going verification of current vaccinations. ***K9 Cabin Dog Day Care requests a copy of the vaccinations done by your vet. All veterinarians will provide this document upon request. You may fax this to (207) 623-9990.***

I have read and understand the following:

1. Responsibility: I understand that I am solely responsible for any harm caused by my dog(s) while my dog(s) is/are attending K9 Cabin Dog Day Care.
2. Representation: I further understand and agree that in admitting my dog(s) to Dog Day Care, K9 Cabin Dog Day Care's staff have relied on my representation that my dog(s) is/are in good health. I am representing that my dog(s) has/have not harmed or shown aggressive or threatening behavior towards any person or any other dog.
3. Liability: I further understand and agree that K9 Cabin Dog Day Care and their staff and volunteers, will not be liable for any problems that develop, provided reasonable care and precautions are followed, and I hereby release them of any liability of any kind whatsoever arising from my dog's/dogs' attendance and participation at K9 Cabin Dog Day Care.

4. Treatment: I further understand and agree that dogs can sometimes receive minor cuts and scratches at day care. In the event of an injury or any other problems that develop with my dog(s) will be treated as deemed best by staff and volunteers of K9 Cabin Dog Day Care, at their sole discretion, and that I assume full financial responsibility for any and all expenses involved. I understand that in the case of an emergency involving my dog/s, the staff of K9 Cabin Dog Day Care will bring my dog/s to a veterinarian. The staff will attempt to use the dog/s own vet if time and distance allows. Otherwise, the staff at K9 Cabin Dog Day Care will primarily use **PINE TREE VET**, Lewiston Emergency Clinic or any other local veterinary clinic. I understand that all veterinary fees and charges are my responsibility and not the responsibility of K9 Cabin Dog Day Care. In Emergencies: Vet will be contacted first, then the owner. (See Medical Release Form)

5. Right of Refusal: K9 Cabin Dog Day Care has the right to reject any dog that becomes aggressive or threatens to harm other dogs or staff, or that is discovered to have fleas, is not current on vaccinations, or becomes ill. Members and/or guests may be removed from K9 Cabin Dog Day Care at any time. Membership may be revoked at management's discretion.

6. Reasonable Care: K9 Cabin Dog Day Care will provide quality and reasonable care for dogs left in its care, but cannot provide constant observation of every dog.

7. Pet Profile: The owner must also complete the Pet Profile.

8. Fees: The fees are subject to change. A notice will be provided at the check in desk for any increases in fees. Daycare - \$21 per day. K9 Cabin Dog Day Care multiple day passes are available reducing per day fee. Boarding - \$29 per calendar day (includes day care all day) days of check-in and check-out are both chargeable days. ( For example, if you drop your dog off at any time during a Friday and pick him/her up at any time on the following Sunday, the per diem/per calendar day fee applies to three (3) days. At this time, K9 Cabin Dog Day Care does not offer price breaks for multiple dogs from the same family or for long-term stays.) \$36 Per Calendar day for In-Home Lodging/Boarding. \$1.00 discount per day if paying by cash/check.

\*Day care and boarding dogs must be picked up by close of business or overnight care will be provided and appropriate lodging charges of \$29. per calendar day (Day of check in and check out are both chargeable days) will be made. \$1.00 discount if paid by cash/check.

\*There is a one day dog day care charge for no shows with less than 24 hour notice.

I understand that if I do not pick up my dog before 6:00 pm, I will be charged an \$11.00 fee per dog per half hour. I understand that if I do not call to cancel regularly scheduled day care appointments 24 hours before 6:30 am on the scheduled day, I will be charged for that day.

All returned checks will incur a \$25.00 fee plus the amount of the returned check. (must be paid with cash)

9. Reservations: Reservations are required. Paid reservations ensure your dog's space. All reservations are final. Any cancellations with appropriate notice are viewed as K9 Cabin Dog Day Care credit for your dog's next visit (to be used within 6 months from the date of canceled reservation). There is a no refund policy. Deposits may be required for Boarding during peak seasons and Holidays. If you have not reserved a day, always call ahead before dropping your dog off for confirmation of available space.

10. Hours of operation:

Day Care: Monday, Wednesday, Friday 7:00 am – 6:00 pm. Saturday and Sunday are by Appointment only until further notice.

Boarding: All dogs can arrive as early as the start of day care and should arrive to K9 Cabin no later than 3pm every day. Please note: The main office door will be closed from 11:30 am – 1:00 pm.

11. Nap time: Nap time is between 11:30 – 1:00 and this is quiet time, we ask that you respect this time. If you are planning a half day of dog day care for the morning please pick your dog up by 11:15 am, if planning a half day for the afternoon please drop your dog off after 1:15 pm. The main office door will be closed every day from 11:30 – 1:00 unless prior arrangements have been made.

12. Photographs, video/digital recordings are taken of the facility, dogs, customers and staff on a regular basis for among other things, use in advertising by K9 Cabin Dog Day Care of Augusta, Maine. I acknowledge that all such images (electronic, negatives and positives), together with prints and the copyrights therein, are the property of K9 Cabin Dog Day Care of Augusta, Maine. I give K9 Cabin Dog Day Care of Augusta, Maine and persons authorized by K9 Cabin Dog Day Care of Augusta, Maine, my consent, permission and authorization, without compensation to me, to use, reproduce and alter the images, in print or electronic format (including on the internet), either alone or in combination with other images, text and graphics. I waive my right to approve the finished photograph, advertising copy, print material or electronic files that may be used in conjunction with the images. I represent that I am at least 18 years of age and acknowledge that the rights granted in this paragraph are irrevocable, worldwide and perpetual, and are binding on my heirs, successors and assigns.

13. I understand that if my dog is not picked up, K9 Cabin will proceed according to the guidelines provided by The State of Maine Abandoned Animal Statute, procedure for handling.

**Maine Revised Statutes §1037-A§1039**

**Chapter 42: ANIMAL WELFARE HEADING: PL 1987, C. 383, §4 (NEW); 1999, C. 254, §16 (RPR)**

**Subchapter 3: CRUELTY TO ANIMALS HEADING: PL 1987, C. 383, §4 (NEW)**

**§1038. Animals abandoned at animal care facilities**

Abandoning an animal at a veterinarian's office, boarding kennel, animal grooming facility or animal day-care facility is a Class D crime. [2005, c. 422, §11 (NEW).]

**3. Ownership of abandoned animal.** When an owner or keeper fails to claim an animal within 10 days of a notice being sent under subsection 2, the veterinarian, kennel, facility or individual who has custody and control of the animal is considered the owner of the animal and shall arrange for its care, including, but not limited to, its adoption, sale or placement with a licensed animal shelter. [ 2005, c. 422, §11 (NEW) .]

**4. Financial obligation.** The disposal of an abandoned animal under this section does not relieve the owner or keeper of the animal of any financial obligation, including, but not limited to, costs incurred for veterinary treatment, boarding, grooming or other care.

**5. Penalty.** In addition to the penalties provided in Title 17-A for a Class D crime, the penalties in section 1031, subsection 3-B also apply.
